<b>FACTS</b>	<b>WHAT DOES BLUESCAPE ENERGY PARTNERS, LLC DO WITH YOUR PERSONAL INFORMATION?</b>
<b>WHY?</b>	Financial companies choose how they share your personal information. Applicable U.S. federal law gives consumers the right to limit some but not all sharing. U.S. federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>WHAT?</b>	The types of personal information we collect and share depend on the product or service you have with us. The information can include: <ul style="list-style-type: none"> <li>▪ <b>Social Security number</b></li> <li>▪ <b>Investment income</b></li> <li>▪ <b>Account balances and account transactions</b></li> <li>▪ <b>Assets and transaction history</b></li> <li>▪ <b>Checking account information and wire transfer instructions</b></li> </ul>
<b>HOW?</b>	All financial companies need to share clients' personal information to run the everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Bluescape Energy Partners, LLC ("Bluescape") chooses to share; and whether you can limit this sharing. We do not disclose nonpublic personal information about our clients or former clients to third parties other than as described below. Where Bluescape does share personal information with a trusted third party, it does so under strict terms that require the information to be used only for the purpose for which it was disclosed, kept confidential and protected by appropriate security safeguards.

How does Bluescape protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with U.S. federal law. These measures include computer safeguards and secured files and buildings.
How does Bluescape collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ <b>Open an account or give us your contact information</b></li> <li>▪ <b>Buy securities or interests in a fund from us</b></li> <li>▪ <b>Tell us where to send money</b></li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	U.S. federal law gives you the right to limit only: <ul style="list-style-type: none"> <li>▪ sharing for affiliates everyday business purposes - information about your creditworthiness</li> <li>▪ affiliates from using you information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. In order to provide you with the services for which you have engaged Bluescape, the company relies on a number of third parties to provide support services, including professional, legal, accounting and technical support.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
